RESOLUTION NO. 045-2020

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE AWARDING A PROPOSAL FOR THE PURCHASE OF A NEW AUDIO SYSTEM TO CROSSFIRE NORTHWEST AUDIO/VISUAL IN AN AMOUNT NOT TO EXCEED THIRTY ONE THOUSAND TWO HUNDRED SEVEN DOLLARS AND SEVENTY TWO CENTS (\$31,207.72) AND AUTHORIZING THE CITY MANAGER TO EXECUTE A PURCHASE ORDER BASED ON SAID PROPOSAL**

**WHEREAS**, the existing audio system at the Cloverdale Performing Arts Center consists of an outdated audio infrastructure system that is necessary to update to ensure compliance with Federal Communication Commission requirements; and

**WHEREAS**, Crossfire Northwest Audio /Visual provided a proposal for a complete audio system in the amount of thirty-one thousand two hundred and seven dollars and seventy-two cents (\$31,207.72); and

**WHEREAS**, the proposal is for a completed system that includes 12 wireless handheld microphone transmitters with lithium-ion rechargeable batteries and networked charging stations / automatic frequency selection. 2 – 8 channel intelligent automatic audio mixers installed in existing audio equipment rack and wired to 2 access point wireless transceivers; and

**WHEREAS**, the proposal includes up to 3 hours technical training of staff on proper use and care of equipment; and

**WHEREAS**, funding for a new audio system was included in Fund 213 - Public Education & Grant (PEG) Fund in the adopted FY 2019/20 budget; and

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Cloverdale hereby awards a proposal for the purchase of a new audio system to Crossfire Northwest Audio/Visual in an amount not to exceed thirty one thousand two hundred and seven dollars and seventy-two cents (\$31,207.72) and authorizes the City Manager to execute a Purchase Order based on aid proposal.
