RESOLUTION NO. 047-2020

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE AWARDING THE CLOVERDALE VISTA VIEW SLIDE REPAIR PROJECT TO PIAZZA CONSTRUCTION, INC. IN THE AMOUNT OF \$363,536.50, AUTHORIZE THE CITY MANAGER TO EXECUTE A CONTRACT WITH PIAZZA CONSTRUCTION, INC., AUTHORIZE AND APPROVE THE OVERALL BUDGET FOR THE PROJECT

WHEREAS, the City of Cloverdale intends to restore Vista View Drive; and

WHEREAS, the City advertised for bid the Cloverdale Vista View Slide Repair Project, City Staff and the City's consultant, Coastland Engineering, reviewed all bids received, and identified Piazza Construction, Inc. as the lowest responsive bidder with a bid of \$363,536.50; and

WHEREAS, Piazza Construction, Inc. is qualified to perform the Cloverdale Vista View Slide Repair Project; and

WHEREAS, the City of Cloverdale has prepared a funding plan sufficient to complete the project plus contingency costs up to \$54,530.40 (15% of bid) and \$80,000 for engineering support by Coastland Engineering, Inc. for a total budget of \$498,066.90.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cloverdale hereby awards the Cloverdale Vista View Slide Repair Project to Piazza Construction, Inc., approves an overall budget of \$498,066.90 and authorizes the City Manager to execute a construction contract with Piazza Construction, Inc. on behalf of the City.

BE IT FURTHER RESOLVED that the City Council approves a budget amendment reallocating funds, in accordance with the funding plan, to fully fund the project.
