A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE AMENDING THE 2018-19 BUDGET TO INCORPORATE FUND 225-PORTERFIELD CREEK TRAILS OPEN SPACE PRESERVE

WHEREAS, the City owns approximately 250 acres of open space property this is accessible by the public for passive recreation. The area now known as Porterfield Creek Trails Open Space, was previously known as Clover Springs Open Space; and

WHEREAS, the Sonoma County Agricultural Preservation and Open Space District purchased the 249 acre Clover Springs property in the fall of 2007 and received an endowment in the amount of \$275,000, with the intent to convey it to the City of Cloverdale for use as a public park and open space preserve; and

WHEREAS, the project is estimated to be fully constructed during fiscal year 2018-19; and

WHEREAS, the budget for this project was unknown at the time the budget was adopted on June 12, 2018; and

WHEREAS, the budget has been prepared and attached to this document as Exhibit A for FY 2018-19.

NOW, THEREFORE IT IS HEREBY RESOLVED, ORDERED AND FOUND that the City Council of the City of Cloverdale, State of California, does hereby approve the incorporation of Fund 225 budget and amend the City of Cloverdale budget for fiscal year 2018-19 as attached in Exhibit A, reducing the projected fund balance from \$102,766 to \$12,404 and completing the project.

Consideration and Adoption of Resolution No. 067-2018, Amending the Fiscal Year 2018-19 Budget to Incorporate Fund 225-Porterfield Creek Trails Open Space Preserve

Background:

The City of Cloverdale owns an approximately 249 +/- acre of open space property that is accessible by the public for passive recreation. The area now called the Porterfield Creek Trails Open Space ("Open Space") was formerly known as the Clover Springs Open Space.

The Sonoma County Agricultural Preservation and Open Space District ("District") purchased the 249-acre Clover Springs property in the fall of 2007 with the intent to convey it to the City of Cloverdale ("City") for use as a public park and open space preserve. The District transferred fee title to the City in 2011 for scenic and natural resource protection, and recreational and educational use. At transfer, the District retained a conservation easement that protects the natural resources and scenic open space values of the property, while allowing for low-intensity outdoor public recreation.

In June of 2011, the District commissioned a draft trail and native plant regeneration plan that was provided to the City at the time of transfer, and was intended to assist the City in their planning for recreational and educational uses of the Open Space property.

In 2014, the District granted to the City \$313,250 of funding to the City to provide management and administration; finalize project plans; conduct CEQA analysis and obtain permits; construct a trail system including bridge crossing and improve Creekside trail to allow for year-round public access; create parking area and design and install signage.

When the City of Cloverdale, Fiscal Year 2018-19 budget was adopted on June 12, 2018, the budget for the Porterfield Creek Trails Open Space was unknown and the budget document noted that the expenditures were To Be Determined "TBD".

Finance staff developed the attached budget and is requesting authorization to amend the Fiscal Year (FY) 2018-19 Budget to incorporate Fund 225 - Porterfield Creek Open Space into the City of Cloverdale's FY 2018-19 Budget. Attached is a resolution (Attachment A) amending the FY 2018-19 Budget to Incorporate Fund 225-Porterfield Creek Trails Open Space Preserve into the budget.

Staff has determined the costs to complete the trail work and remaining improvements (i.e. water fountain, pole gate, fencing etc.) within the Open Space to be \$90,562 (Attachment B). The fund balance as of July 1, 2018 is projected to be \$102,766. Completion of the Open Space improvements is expected to result in a fund balance of \$12,204.

Options

- 1. Adopt Resolution No. 067- 2018, approving the budget amendment.
- 2. Do not approve the resolution and provide other direction to staff.

Budget/Financial Impact

Amend the FY 18/19 Budget to include \$90,562 in Fund 225-Porterfield Creek Trails Open Space Preserve expenditures reducing the fund balance to \$12,204 and complete the project.
