# CITY OF CLOVERDALE CITY COUNCIL RESOLUTION NO. 024-2019

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE AUTHORIZING THE CITY MANAGER TO EXECUTE THE THIRD AMENDMENT TO THE PROFESSIONAL SERVICES AGREEMENT WITH ROYSTON, HANAMOTO, ALLEY & ABEY, INC. TO DEVELOP A MASTER PLAN FOR SECOND STREET CITY PARK AND AMENDING THE 2018-19 BUDGET

**WHEREAS**, the City Council identified intense usage and differed maintenance with Second Street City Park; and

**WHEREAS**, the City Council appointed an Ad-hoc Committee to address issues associated with Second Street City Park; and

**WHEREAS**, the Ad-hoc Committee recommended, and City Council engaged the services of Royston, Hanamoto, Alley & Abey, Inc. to develop and refine design concepts for the Second Street City Park improvements; and

**WHEREAS**, Royston, Hanamoto, Alley & Abey, Inc. prepared and presented a design concepts for the Second Street City Park improvements; and

**WHEREAS**, City Council and Ad-hoc Committee reviewed the design concepts and consented to a preferred concept for the Second Street City Park improvements; and

**WHEREAS**, City Council recommended advancing the study of the Second Street City Park improvements by producing a Master Plan; and

WHEREAS, a First Amendment was authorized for the contract with Royston, Hanamoto, Alley & Abey, Inc. for additional scope of services related to the preparation of the Second Street City Park Master Plan with a not-to-exceed compensation of \$28,235 (an increase of \$20,255); and

**WHEREAS,** a Second Amendment was authorized for the contract with Royston, Hanamoto, Alley & Abey, Inc. for additional scope of services related to incorporating a proposed water basin as part of the Downtown Drainage Improvement Project into the Second Street City Park Master Plan with a not-to-exceed compensation of \$39,194 (an increase of \$8,370); and

**WHEREAS**, at the request of City Council, Royston, Hanamoto, Alley and Abey, Inc. prepared and presented to City Council an overview of the final master plan results; and

**WHEREAS**, Royston, Hanamoto, Alley & Abey, Inc. submitted a detail scope work and cost proposal to the City of Cloverdale for Professional Services for the additional scope of services related to a final presentation to City Council; and

**WHEREAS,** the Professional Service Agreement, Payment Terms and Not to Exceed Amount for Royston, Hanamoto, Alley & Abey, Inc. is amended from \$39,194 to \$43,519 (an increase of \$4,325 for professional services), which will be funded by the General Fund.

NOW, THEREFORE, BE IT RESOLVED that the Cloverdale City Council authorizes the City Manager to

1. Execute Amendment No. 3 to the professional services agreement between Royston, Hanamoto, Alley & Abey, Inc. and the City of Cloverdale for the additional scope items related to the Council meeting presentation of the final Master Plan for the Second Street City Park in an amount of \$4,325.

2. Amend the Fiscal Year 2018-19 budget for the Parks Department, general fund, expenditure account for Professional Services (100-40-404-42135-000), increasing it by \$4,325 which will reduce the unencumbered fund balance.
