RESOLUTION NO. 59-2019

**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE
AUTHORIZING THE CITY MANAGER, CITY ENGINEER, OR THEIR
DESIGNEE TO ACCEPT VOLUNTARY DEDICATIONS OF REAL PROPERTY
FOR PUBLIC PURPOSES ON BEHALF OF THE CITY OF CLOVERDALE**

WHEREAS, Section 17.12.240 of the Cloverdale Municipal Code provides that the City may, at its option, accept offers of real property for dedication by appropriate means; and

WHEREAS, examples of such dedications, among many others, include: (1) a dedication of right-of-way for installation of curb, gutter, and sidewalk; and (2) dedication of an easement for location of streets and improvements; and

WHEREAS, pursuant to section 7050 of the Government Code, a property owner may voluntarily offer dedications of real property to the City of Cloverdale for public purposes; and

WHEREAS, pursuant to section 27281 of the Government Code, any acceptance of any deed or grant conveying any interest or easement upon real property to the City of Cloverdale must be evidenced by a resolution of acceptance; and

WHEREAS, Council authorization of the City Manager or City Engineer to accept dedications administratively would eliminate the need for Council action when a dedication of real property for public purposes is voluntarily offered on behalf of the City of Cloverdale.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cloverdale hereby authorizes the City Manager, City Engineer, or their designee, to: (1) administratively accept voluntary dedications of real property for public purposes on behalf of the City of Cloverdale; and (2) to execute the necessary documents for the acceptance of the aforementioned voluntary offers of dedication of real property for public purposes on behalf of the City of Cloverdale.
