RESOLUTION NO. 64-2019

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE ACCEPTING THE CONSTRUCTION OF THE CITY OF CLOVERDALE, ROCKYDALE LANE ACCESSIBILITY IMPROVEMENTS PROJECT AS COMPLETE AND DIRECTING THE CITY ENGINEER TO FILE A NOTICE OF COMPLETION WITH THE COUNTY RECORDER'S OFFICE**

**WHEREAS**, in accordance with California Public Contract Code Section 20162 and other applicable law, the City of Cloverdale solicited bids for the *City of Cloverdale, ROCKYDALE LANE ACCESSIBILITY IMPROVEMENTS* project (Project); and

**WHEREAS**, by Resolution No. 015-2018 adopted on February 27, 2019, the City Council found the bid submitted by Duran Grading and Paving, Inc., to be the lowest responsive bid and awarded the Project to Duran Grading and Paving, Inc., in the amount of \$24,500.00, conditioned upon Duran Grading and Paving, Inc.'s timely executing the Project contract and submitting all required documents, and authorized and directed the City Manager to execute the Project contract; and

**WHEREAS**, the Engineering Department has reviewed all mandatory documents submitted by the contractor, deemed them complete and accurate; and

**WHEREAS**, the Project has been inspected by the Engineering Department and deemed complete in accordance with the terms of the contract and to the City's satisfaction; and

**WHEREAS**, the Project has been completed within the bid amount and with no change orders; and


**NOW, THEREFORE, BE IT RESOLVED**, that the City Council of the City of Cloverdale hereby: (1) accepts as complete the project entitled, Rockydale Lane Accessibility Improvements Project, with a final contract amount of \$24,500.00; (2) authorizes and directs the City Engineer to file a Notice of Completion concerning the Project with the Sonoma County Clerk's Office within ten (10) days of the date of this Resolution; and (3) authorizes and directs Staff to release all undisputed retention, within sixty (60) days of the date of this Resolution and in accordance with the terms of the Project contract, California Public Contract Code Section 7107 and applicable law.
