RESOLUTION NO. 046-2020

A RESOLUTION OF THE CITY OF CLOVERDALE REJECTING A BID PROTEST SUBMITTED BY GHILOTTI BROTHERS AND AWARDING THE SOUTH CLOVERDALE BLVD @ HEALDSBURG AVE. ACCESSIBILITY IMPROVEMENTS PROJECT TO M3 INTEGRATED SERVICES, INC. IN THE AMOUNT OF \$189,740.60, AUTHORIZE THE CITY MANAGER TO EXECUTE A CONTRACT WITH M3 INTEGRATED SERVICES, INC., APPROVE A BUDGET AMENDMENT, AUTHORIZE AND APPROVE THE OVERALL BUDGET FOR THE PROJECT”

WHEREAS, the City of Cloverdale intends to reconstruct the sidewalks, curb ramps and crosswalk located at the intersection of Healdsburg Avenue and South Cloverdale Blvd.; and

WHEREAS, the City advertised for bid the South Cloverdale Blvd @ Healdsburg Ave. Accessibility Improvements Project. City Staff and the City’s consultant, MOE Engineering, reviewed all bids received, and identified M3 Integrated Services, Inc. as the lowest responsive bidder with a bid of \$189,740.60; and

WHEREAS, the City of Cloverdale staff and the City Attorney reviewed the bid protest issued by Ghilotti Brothers, Inc. and found the defects reported in the M3 bid to be minor and within City Council authority to waive; and

WHEREAS, M3 Integrated Services, Inc. is qualified to perform the South Cloverdale Blvd @ Healdsburg Ave. Accessibility Improvements Project; and

WHEREAS, the City of Cloverdale has prepared a funding plan sufficient to complete the project plus contingency costs up to \$18,974.00 (10% of bid) for a total budget of \$208,714.60.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cloverdale hereby awards the South Cloverdale Blvd @ Healdsburg Ave. Accessibility Improvements Project to M3 Integrated Services, Inc., approves an overall budget of \$208,714.60 and authorizes the City Manager to execute a construction contract with M3 Integrated Services, Inc. on behalf of the City.


BE IT FURTHER RESOLVED that the City Council rejects the bid protest issued by Ghilotti Brothers, Inc. on the grounds that the reported defects in the bid prepared by M3 Integrated Services, Inc. are minor and within Council authority to waive.

BE IT FURTHER RESOLVED that the City Council approves a budget amendment reallocating funds, in accordance with the funding plan, to fully fund the project.


