RESOLUTION NO. 088-2020

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE AUTHORIZING THE CITY MANAGER TO PROCURE BUDGETED ROUTINE GOODS FOR THE WATER ENTERPRISE FUND, THE WASTEWATER ENTERPRISE FUND, AND THE GENERAL FUND PARKS AND RECREATION DIVISION WHOSE ANNUAL AGGREGATE COST TOTALS EXCEED THE CITY MANAGER'S PURCHASING AUTHORITY**

**WHEREAS**, the Public Works Department regularly purchases goods needed to operate the City's Parks & Recreation Division (General Fund 404), Water and Wastewater Systems (Enterprise Funds 600 & 630); and

**WHEREAS**, the City Council has reviewed the budgeted items and has approved the Fiscal Year 2020-2021 Budget; and

**WHEREAS**, the Fiscal Year Budget 2020-2021 includes these goods; and

**WHEREAS**, attached to this resolution are referenced purchase orders (PO's) that list out the routine planned purchases for Fiscal Year 2020-2021; and

**WHEREAS**, the aggregate annual total of these goods and services exceeds the City Manager's annual purchasing limit; and

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Cloverdale hereby authorizes the City Manager to purchase aforementioned budgeted goods whose annual aggregate costs exceed the City Manager's purchasing limits for the General Fund Parks & Recreation Division 40-404, Water Enterprise Fund 600 and the Sewer Enterprise Fund 630.


