RESOLUTION NO. 089 –2020

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE AUTHORIZING THE CITY MANAGER TO EXECUTE A FIVE-YEAR SOFTWARE SERVICE AGREEMENT WITH OPENGOV IN A FORM APPROVED BY CITY ATTORNEY FOR BUDGETING AND PLANNING AND PERMITTING, LICENSING AND CODE ENFORCEMENT CLOUD-BASED SOFTWARE SERVICES IN AN AMOUNT NOT TO EXCEED \$108,770 IN YEAR ONE AND \$52,420 IN YEARS TWO-FIVE AND AMEND THE FY 2020-21 BUDGET

WHEREAS, the City is working to integrate the use of technology into our business process as a way to become more efficient and transparent and offer convenience to the citizens and contractors; and

WHEREAS, OpenGov is qualified to provide cloud-based software to assist in budget and permitting, licensing and code enforcement processes; and

WHEREAS, the annual subscription cost is \$52,420 for years one through five. Year one also includes \$56,350 for product configuration, setup and training. The Fiscal Year 2020-21 budget currently includes \$14,000 for Permitting, Licensing and Code Enforcement (100-50-502-42210-000 and 100-50-602-42210-000). The remaining \$94,770 would be funded with General Fund (100-20-201-42150-000) reserves, less any CARES Act Funds available. General fund expenditures would be captured at year-end in overhead and would be partially offset by Water, Sewer and Airport Funds.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cloverdale hereby approves a Five-Year Professional Services Agreement with OpenGov to provide cloud-based software services for Budget and Planning and Permitting, Licensing and Code Enforcement and authorizes the City Manager to execute said agreement on behalf of the City.
