**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE ACCEPTING PUBLIC IMPROVEMENTS PERFORMED BY RESOURCE DEVELOPMENT COMPANY FOR THE CLOVERDALE WATER TREATMENT PLANT FILTER NO. 2 REHABILITATION PROJECT AND AUTHORIZING THE CITY MANAGER TO RELEASE UNDISPUTED PERFORMANCE BOND AND RETENTION**

**WHEREAS**, On February 12, 2020 the City of Cloverdale City Council awarded the Cloverdale Water Treatment Plant Filter No. 2 Rehabilitation Project to Resource Development Company; and

**WHEREAS**, Resource Development Company has performed the work and City Staff have determined that all work has been completed in conformance with City Standards and the contract; and

**WHEREAS**, final payment from the budget account authorized under Resolution 009-2020 is now due to the contractor, Resource Development Company.



**BE IT FURTHER RESOLVED** that the City Council of the City of Cloverdale authorizes the City Manager to release all undisputed bond(s) obtained by the contractor for the performance of the project.
