RESOLUTION NO. 094-2020

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE APPROVING AMENDMENT NO. 1 TO THE PROFESSIONAL SERVICES AGREEMENT WITH MOE ENGINEERING TO PROVIDE ADDITIONAL SERVICES FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) IN AN AMOUNT NOT TO EXCEED \$14,115; AUTHORIZE THE CITY MANAGER TO EXECUTE SAID AMENDMENT; AND AMEND THE FY 2020-21 BUDGET TO REFLECT THIS CHANGE

WHEREAS, the City Council on June 12, 2019 approved a Professional Services Agreement with GHD to complete the Capital Improvement Plan the estimated costs was \$73,660; and

WHEREAS, the need for additional inspection and construction management services associated with the project are required; and

WHEREAS, City Staff requested Moe Engineering to provide a scope of work for the additional analysis required to complete the project; and

WHEREAS, Consultant proposes to increase the total "Not to Exceed Amount" by \$14,115 to perform the tasks outlined in the attached Scope of Work; and

WHEREAS, City staff is requesting that the City Council approve an amendment to the Professional Services Agreement with Moe Engineering to revise the Scope of Work and payment terms and not to exceed amount;

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cloverdale hereby approves Amendment No. 1 to the Professional Services Agreement with Moe Engineering to revise the Scope of Work and increase the not to exceed amount by \$14,115; authorizes the City Manager to execute said amendment on behalf of the City; amend the FY 2020-21 CDBG Budget (Fund 224) to include these expenditures and transfer funds from Measure M:Streets Fund 212 to cover the additional expenditures.
