RESOLUTION NO. 097-2020

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE ENDORSING MEASURE DD ON
THE NOVEMBER 3RD, 2020 BALLOT KNOWN AS THE SONOMA COUNTY TRANSPORTATION
AUTHORITY (SCTA) GOSONOMA TRANSPORTATION SALES TAX MEASURE**

WHEREAS, Sonoma County Transportation Authority (SCTA) administers Measure M ¼-cent transportation sales tax for funding transportation projects in Sonoma County; and

WHEREAS, the existing Measure M ¼-cent transportation sales tax will expire on March 31, 2025; and

WHEREAS, to maintain the County's current status as a self-help county and to deliver critical transportation projects, SCTA Board of Directors recommended a sales tax ordinance and expenditure plan for the November 2020 ballot, collectively named the "GoSonoma Act"; and

WHEREAS, the City Council of the City of Cloverdale recommended approval of the GoSonoma Act Expenditure Plan of the Sonoma County Transportation Authority on June 10, 2020; and

WHEREAS, SCTA's Board of Directors requested the Board of Supervisors to call an election for the approval of the ordinance, consolidated with the general election of November 3, 2020; and

WHEREAS, the GoSonoma Act placed on the ballot as Measure DD asks voters whether the SCTA should extend its existing ¼-cent sales tax for an additional 20 years through March 31, 2045; and

WHEREAS, Measure DD would continue to be used exclusively to fund transportation improvements within Sonoma County (including fixing local streets; improving transportation corridors; increasing bus transit service and improving alternatives to cars to reduce greenhouse gas emissions; and improving safety for cyclists, pedestrians, and drivers), as set forth in detail in the Expenditure Plan; and

WHEREAS, the tax revenue generated by Measure DD will support an Annual Pothole Fund of approximately \$9.9 Million annually to smooth and maintain roads of which an estimated annual sales tax funding of \$157,000 will be dedicated to the City of Cloverdale.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cloverdale hereby endorses Measure DD on the November 3rd 2020 Ballot known as the Sonoma County Transportation Authority (SCTA) GoSonoma transportation sales tax measure.

The foregoing Resolution No. 097-2020 was duly introduced and adopted by the City Council of the City of Cloverdale at its regular meeting held on the 14th day of October 2020, by the following roll call vote:


