A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE APPROVING A FY 2020-21 BUDGET AMENDMENT TO THE PUBLIC SAFETY IMPACT FUND IN THE AMOUNT OF \$52,687.60; AND APPROVING AN AGREEMENT WITH MATT MAZZEI CHEVROLET AND PRECISION WIRELESS IN AN AMOUNT NOT TO EXCEED FORTY SEVEN THOUSAND EIGHT HUNDRED NINETY TWO DOLLARS AND EIGHTY TWO CENTS (\$47,892.82) FOR THE PURCHASE OF ONE 2021 DODGE CHARGER (LDDE48) BASE MODEL POLICE VEHICLE AND NECESSARY EQUIPMENT AND INSTALLATION FROM PRECISION WIRELESS PLUS A 10% CONTIGENCY FOR POTENTIAL COST OVERRUNS AND AUTHORIZING THE CITY MANAGER TO EXECUTE SAID AGREEMENT

WHEREAS, the police department owns a 2013 Chevrolet Tahoe police vehicle that has in excess of 104,000 miles and regularly has mechanical problems resulting in high maintenance costs and concern for officer safety; and

WHEREAS, the Chevrolet Tahoe has absorbed \$12,000 in maintenance fees and has reached the end of its life cycle; and

WHEREAS, in order to continue to provide public safety services, the police department must have reliable vehicles to ensure officers are capable of responding to emergencies; and

WHEREAS, the department intended on requesting additional Vehicle Capital Outlay funds during the 2020/2021 budget process to purchase one new Dodge Charger police vehicle to replace the aging 2013 Chevrolet Tahoe however, due to the Coronavirus Pandemic, the department removed the funding request based on anticipated revenue shortfall; and

WHEREAS, the police department is seeking to purchase a new fully equipped Dodge Charger police vehicle to better serve the needs of the department and community; and

WHEREAS, the purchase of a new police vehicle will ensure officer safety when responding to priority emergencies and reduce maintenance expenses that are anticipated in the future; and

WHEREAS, the specifications for these vehicles and equipment were provided to dealerships in accordance with the bid process; and

WHEREAS, the City received three bids meeting our specifications with the lowest being Matt Mazzei Chevrolet; and

WHEREAS, Public Safety Impact Fund are available to use for this project (510.00.000.44110.000) and will leave an estimated fund balance of \$69,138.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cloverdale hereby approves an Agreement with Matt Mazzei Chevrolet and Precision Wireless in an amount not to exceed \$47,892.82 for the purchase of one Dodge Charger base model police vehicle and installation and equipment and further authorizes the City Manager to execute said agreement on behalf of the City and amends the Fiscal Year

2020-21 Budget to include expenditures up to \$52,687.60 (includes 10% contingency) in Fund 510 Public Safety Impact Fund.
