RESOLUTION NO. 033-2021

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE AWARDING CLOVERDALE 2ND STREET PARK RENOVATIONS PROJECT TO M3 INTEGRAL SERVICES, INC. IN THE AMOUNT OF \$49,340.00 AUTHORIZE THE CITY MANAGER TO EXECUTE A CONTRACT WITH M3 INTEGRAL SERVICES, INC AUTHORIZE A BUDGET AMENDMENT AND APPROVE OVERALL BUDGET FOR THE PROJECT

WHEREAS, the City of Cloverdale intends to perform repair and enhancement of the 2nd Street City Park Trail in accordance with the Park Master Plan; and

WHEREAS, the City advertised for bid the Cloverdale 2nd Street Park Renovations Project, The City's consultant, MOE Engineering and City Staff reviewed all bids received, and identified M3 Integral Services, Inc, Inc. as the second lowest responsive bidder with a bid of \$49,340.00; and

WHEREAS, M3 Integral Services, Inc. is qualified to perform the Cloverdale 2nd Street Park Renovations Project; and

WHEREAS, the City of Cloverdale has prepared a funding plan sufficient to complete the project plus contingency costs up to \$4,934.00 (10% of bid) for a total budget of \$54,274.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cloverdale hereby awards the Cloverdale 2nd Street Park Renovations Project to M3 Integral Services, Inc., approves an overall budget of \$54,274 and authorizes the City Manager to execute a construction contract with M3 Integral Services, Inc. on behalf of the City.

BE IT FURTHER RESOLVED that the City Council approves a budget amendment reallocating Community Development Block Grant (CDBG) funds totaling \$42,200.40 to fully fund the project.


