**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE  
AMENDING THE FISCAL YEAR 2021-22 BUDGET TO INCLUDE THE USE OF  
UNSPENT BOND PROCEEDS FOR THE SAFE ROUTES TO SCHOOL PHASE II  
PROJECT**

**WHEREAS**, On March 11, 2020, the Cloverdale City Council approved a contract and award of bid to TEAM Ghilotti for the Safe Routes to School Phase II Project; and

**WHEREAS**, on December 9, 2020, the City Council Accepted the Public Improvements; and

**WHEREAS**, the City obtained a \$100,000 grant from the Federal Highway Administration (FHWA), the grant had a Project End Date "PED" of July 24, 2020. Due to delays and the timing of the PED extension the City was eligible for \$17,927.83 of the grant funds, the remaining grant funds in the amount of \$82,072.17 are ineligible; and

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Cloverdale hereby approves a Budget Amendment to the Fiscal Year 2021-22 transferring funds in the amount of 82,072.17 from Fund 250 Non-Housing Unspent Bond Proceeds to cover the remaining costs associated with the Safe Routes to School Phase II Project.


