**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE
APPROVING A PROFESSIONAL SERVICES AGREEMENT WITH KLH
CONSULTING, INC. TO PROVIDE MANAGED IT SERVICES AND
AUTHORIZING THE CITY MANAGER TO EXECUTE SAID AGREEMENT**

WHEREAS, the City of Cloverdale has nine departments that heavily rely on our information technology and online systems; and

WHEREAS, the City is in need of additional Information Technology services, including Managed IT Services; and

WHEREAS, the City has not full-time staff dedicated to information technology, nor have staff with the knowledge or expertise to provide this service; and

WHEREAS, KLH Consulting, Inc. is qualified to provide Managed IT Services; and

WHEREAS, the budgets for Fiscal Years FY 2022-23 and 2023-24 each have \$192,000 included for IT Services.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cloverdale hereby approves a Professional Services Agreement with KLH Consulting, Inc to Managed IT Services and authorizes the City Manager to execute said agreement on behalf of the City, in a form approved by the City Attorney.
