**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE  
SETTING THE AD VALOREM TAX RATE FOR PUBLIC EMPLOYEE  
RETIREMENT SYSTEM RETIREMENT BENEFITS FOR FISCAL YEAR 2022-2023**

**WHEREAS**, the City of Cloverdale has entered into a contract with the Public Employees' Retirement System of the State of California for the provision of retirement and related benefits to the employees of the City of Cloverdale, and pursuant to previously established voter authorization, the City of Cloverdale is authorized to establish the levy for the current fiscal year in order to fund its responsibilities under the contract; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Council that an Ad Valorem tax rate for fiscal year 2022-2023 be levied upon property in the City of Cloverdale for the above purpose in an amount of \$0.098 per one hundred dollars of full assessed valuation; and

**BE IF FURTHER RESOLVED** that the County Assessor, Auditor, Tax Collector and other appropriate officials of the County of Sonoma are hereby authorized and directed to spread the specified assessment upon the tax rolls of all taxable property within the City of Cloverdale in the County of Sonoma, and to receive, collect, and disburse the same in accordance with law and the agreement between the City of Cloverdale and the County of Sonoma.


