RESOLUTION NO. 076- 2022

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLOVERDALE AWARDDING CLOVERDALE PLAZA PARK RESTROOM PROJECT TO REGE CONSTRUCTION, INC. IN THE AMOUNT OF \$76,657.00, AUTHORIZE AND APPROVE AN OVERALL PROJECT BUDGET \$84,322.70 AND AUTHORIZE THE CITY MANAGER TO EXECUTE A CONTRACT WITH REGE CONSTRUCTION, INC.

WHEREAS, the City of Cloverdale intends to construct a public restroom at Cloverdale's Plaza Park; and

WHEREAS, the City advertised for bid the Cloverdale Plaza Park Restroom Project; and

WHEREAS, The City's consultant, MOE Engineering and City Staff reviewed all bids received, and identified Rege Construction, Inc. as the lowest responsive bidder with a bid amount of \$76,657.00; and

WHEREAS, Rege Construction, Inc. is qualified to perform the Cloverdale Plaza Park Restroom Project; and

WHEREAS, the City of Cloverdale has prepared a funding plan sufficient to complete the project plus contingency costs up to \$7,657.70 (10% of bid) for a total budget of \$84,322.70.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Cloverdale hereby

1. Awards the Cloverdale Plaza Park Restroom Project to Rege Construction, Inc.,
2. Approves an overall project budget of \$84,322.70 and
3. Authorizes the City Manager to execute a construction contract with Rege Construction on behalf of the City.


